- 11. CEO REPORT: Trump's budget is ugly for our people. We need to speak to our legislators individually. County boards will be asked to pass resolutions in support of CSBG and CDBG to present to legislators. Shawano County has already done CDBG support resolution. If we wouldn't be doing our programs, then the counties would have to do it. As of January 1, 2018, one third of the Board has to be low-income themselves, they can't represent low-income. We are working with WISCAP and state legislators to double funding for skills enhancement (Steps to Success) and jobs/business development (Create Your Own Opportunities) across the state. The City of Oconto applied for community development block grant-public facilities for us for the new building. CEO will be meeting with legislators and regulators in Washington DC in July for National Association to End Homelessness. Rainbow House is moving by July 1, 2017. Board information will be on the new website, so the Board can see everything on the website and be able to print it out also.
- 12. <u>PUBLIC COMMENTS:</u> July 14, 2017 at the Meyer Theater in Green Bay; Let Be Frank Productions is putting on "Getting Pickled in Oconto, Bond Style," a musical regarding the Bond Pickle Factory.
