SHORTLY THEREAFTER THE CEO DISCOVERED THE FORM 990 HAD NOT BEEN COMPLETED NOR HAD AN EXTENSION BEEN FILED. EXISTING ACCOUNTING STAFF DID NOT HAVE THE EXPERTISE TO COMPLETE THE ANNUAL RETURN AND THE NEW CFO WAS NOT HIRED UNTIL 09-16-2016. AN OUTSIDE ACCOUNTING FIRM WAS HIRED TO COMPLETE THE FORM 990 AND PROVIDE IT TO THE NEW CFO FOR REVIEW AND TRANSMITTAL. THE OUTSIDE ACCOUNTING FIRM PROVIDED THE COMPLETED RETURN ON 10-25-2016.
